Program reduces emergency transfers for long-term care residents

Currently offered only in Capital District Health Authority

program that sees family physicians give regular and consistent care to residents in long-term care facilities has resulted in 50 per cent fewer emergency department transfers in the three years since its implementation.

Care by Design was created under the leadership of family physician Barry Clarke, and imple-

mented in the Capital District Health Authority in 2010. Its primary goal is to reduce transfers of patients to emergency departments. This is done by increasing physician involvement in the management of the patient's health care needs.

"Weekly rounds by family physicians provide a proactive management style which residents themselves and their family members truly appreciate. Staff at the facility and physicians form a team approach in meeting

health-care needs of the residents and in so doing raises the bar in quality of health care for these frail individuals," said Dr. Clarke.

The program is currently offered only in the Capital district. Although physicians elsewhere in the province are interested in the program it's not yet funded in any other district.

How the program works

Care by Design sees the family physician attend the facility once a week to conduct rounds. Most physicians cover 12-36 residents living in one unit. A nurse familiar with the residents discusses with the physician any health concerns. Preamble requirements are that physicians may only claim a visit when there has been a medically necessary specific request by nursing home staff, the patient or their family. Physicians can't claim for a routine "rounds" visit.

Outside of weekly rounds, the physician is available by telephone from 8 a.m. until 5 p.m., Monday to Friday, to address issues requiring urgent attention.

The 55 physicians who are participating in Care by Design are part of an on-call roster and rotate, on a weekly basis, providing coverage after hours and on holidays. There's compensation for on-call coverage and fee-for-service payment for eligible service encounters.

Long-term care clinical geriatric assessment

The physician completes the physician component of the long-term care clinical geriatric assessment (CGA) every six to 12 months. This service is billed to MSI and specific billing rules apply. The CGA is a multi-disciplinary assessment process that provides a comprehensive summary of the resident's medical history, medications, level of function, frailty score, advanced directives, EPOA and GFR. The CGA can be used by all health-care providers to quickly access health information that's up to date for the resident.

Medication review

A medication review (MR) is done by the physician, in collaboration with the nurse and pharmacist as required, every six months. This service is also billed by the physician to MSI and specific billing rules apply.

The purpose of an MR is to reduce the number of medications used as this can create many problems with the senior population.

Advanced care paramedic

The advanced care paramedic (ACP) is part of the health-care team, working with Care by Design in the Halifax Regional Municipality. These paramedics have an additional level of training for the health-care needs of people living in long-term care facilities and can evaluate residents who are more ill and may require transfer to hospital for further management.

ACPs work collaboratively with the patient, nurse, emergency department physician, and family physician to best manage the health crisis. Transfers to the emergency department can be avoided when the care is well managed in the long-term care facility.
